THE PROBLEM:

Georgia's Animal Shelters and Rescues are in crisis and euthanizing healthy, adoptable dogs and cats every day

Georgia has had an overpopulation of dogs and cats for many years, but the Pandemic and the following financial crunch, from 2021 through today, has made it unmanageable.

The pandemic shut down the operations of most spay/neuter clinics, enabling thousands of pets to have litters of unwanted puppies or kittens, and they keep pouring in.

Unwanted pets keep coming into GA shelters, but adoptions and transfers out have dropped significantly, creating a bottleneck of homeless dogs and cats with nowhere to go.

Even shelters with multi-million-dollar budgets, and those that haven't euthanized animals for space in years, are having to kill healthy, adoptable dogs, puppies, cats and kittens to make space for more incoming animals.

Georgia's euthanasia rate continues to climb ...

The rate at which dogs aren't making it out of the shelter is up almost 50% in 2022 versus 2021.

THE COST OF THE PROBLEM:

Having more cats and dogs than it has homes for costs Georgians approx. \$136 million annually:

Animal Welfare Non-Profits:

\$76 million

Municipal Animal Shelters:

\$60 million

GRAND TOTAL

\$136 million

These amounts are expenses only and <u>DO NOT INCLUDE Capital Expenditures</u> (such as purchases of new ACO trucks, equipment, shelter facilities).

This data demonstrates that CONTROLLING the HOMELESS PET POPULATION is an important need of Georgia's taxpayers that is NOT BEING MET.

Georgia's non-profit animal welfare organizations, funded by private citizens are picking up 56%, more than half, of the \$136 million cost to the state.

That means thousands of Georgians are picking up the tab both privately AND through their taxes to clean up a problem they didn't create.

While more than 70% of Georgia's households contain at least one pet, and more than 50% of those households contain more than one pet.


THE BOTTOM LINE is, WE NEED A DIFFERENT APPROACH!

Till now, most of that \$136m has been used <u>re-actively</u> to handle the <u>already existing</u> overabundance of pets.

Our proposal switches Georgia's approach to a more pro-active one, one that seeks to prevent homeless pet overpopulation through addressing some of its causes.

Georgia should invest in PRO-ACTIVE preventive measures because:

- 1. We cannot adopt our way out of the problem of having more dogs and cats than we have homes for.
- 2. We cannot donate our way out of the problem of having more dogs and cats than we have suitable homes for.



SHIFTING GEORGIA'S APPROACH...

The goal of Georgia's official public policy on homeless pets should be:

"LET'S PREVENT GEORGIA'S DOGS AND CATS FROM ENTERING ANIMAL SHELTERS IN THE FIRST PLACE"

This proposal seeks to do that by:

- 1. raising public awareness of the homeless pet crisis & the need to fix our pets
- 2. providing free pet education & access to available pet owner resources



As it stands now, our animal control agencies spend most of their time picking up strays, dumped animals and neglected owned animals, INSTEAD of doing their primary job which is educating the public and enforcing the law.

Our statewide animal welfare infrastructure, which includes the GA Dept. of Agriculture, is stretched beyond its resources due to the sheer number of homeless dogs and cats.

OUR PROPOSAL SEEKS TO ADDRESS SOME OF THE REASONS PETS END UP IN SHELTERS:

SOLUTION:

Too many Georgians get their first pet without knowing how to train, contain, and care for them properly, or not being aware of the financial and lifetime commitment it requires

Some of Georgia's dog and cat owners are not spaying or neutering their pets because they are not aware of the shelter crisis due to a lack of good homes

The Pet Education Website, the PSA Campaign and the Pet Owner Resources Database will be built in the first year and then maintained each year for the next 4 years under a pilot program.

After 4 years of operation, these 3 program components will be evaluated for performance results in conjunction with current shelter statistics to decide whether to continue or dissolve.

Pet Education Portal

The goal of the online Pet Education Website is to address the lack of education among some Georgians on how to:

- · Choose,
- · care for,
- · Contain,
- Train, and
- Socialize their pets
- Keep communities safe from dog bites both owners and non-owners
- Free to anyone with a Georgia zip code
- Tailored to different age groups
- Could be used for:
 - Individual parents or kids
 - Animal shelters adopting out pets
 - Animal rescue groups adopting out pets
 - Public or private schools across Georgia
- Will be built using content from free sources and local SMEs from Georgia who will be paid for their time to produce materials.

PUBLIC SERVICE ANNOUNCEMENT CAMPAIGN

One reason not enough of Georgia's dog and cat owners are spaying or neutering their pets is that they are simply NOT AWARE that:

SPAY AND NEUTER

- Shelters are full and euthanizing healthy dogs and cats for space
- · There aren't enough homes for the puppies or kittens their pet could produce

Most folks wouldn't let their pet get pregnant if they know those offspring will end up homeless, in an animal shelter with euthanasia as a possible fate.

A statewide Public Service Announcement campaign would get this message out so that pet owners who can afford to and have access to a vet will actually get their pets fixed, preventing more homeless litters of kittens and puppies.
